# Subject: The Constitution (97th Amendment) Act, 2011- reg.

Sir,

I am directed to say that the Constitution (97<sup>th</sup> Amendment) Act, 2011 relating to cooperative societies, which has come into force w.e.f. 15.02.2012 vide Gazette Notification dated 08.02.2012, provides for a maximum period of one year from the date of its commencement to amend the state laws relating to cooperative societies including Multi-state Cooperative Societies (MSCS), if required, to make them consistent with the provisions of the amendment. Accordingly, the States/UTs have been requested to amend their State Cooperative Societies Acts on or before 14.02.2013.

2. The Multi-state Cooperative Societies are governed under the provisions of a Central Act i.e. Multi-State Cooperative Societies (MSCS) Act, 2002 through the Central Registrar of Cooperative Societies appointed by this Department. At present, there are around 900 Multi-state Cooperative societies registered under the provisions of the MSCS Act, 2002 in the country. A list of the MSCS registered in your State is enclosed herewith.

3. Article 243 ZK of the Constitution (97<sup>th</sup> Amendment) Act, 2011 provides that "the superintendence, direction and control of the preparation of electoral rolls for, and the conduct of , all elections to a co-operatives society shall vest in such an authority or body, as may be provided by the Legislature of a State, by law". Hence, election of the Board of Directors of MSCS after 14.2.2013 are required to be conducted by constituting an election authority or body by this Department in accordance with the Constitutional Amendment.

4. Government of India has already initiated steps to amend the MSCS Act, 2002. However, the same is expected to take some more time. After amending the MSCS Act, 2002, an election authority or body will be constituted which will be responsible for conducting election to the Board of Directors of MSCSs.

5. Since cooperation is a state subject, the State Governments/UTs have adequate infrastructure and expertise in this field. Article 243ZK of the above constitutional amendment Act also provides that the election of the members of the Board to be conducted in a time bound manner before the expiry of the outgoing board. You are therefore, requested to kindly depute officers of the State Govt. to the MSCSs having the registered office in your State/UTs to find out whether the tenure of the board of such MSCS(s) has expired or the date on which their tenure will expire, please also verify the registered address as registered with this/office and if it has changed, the same may also be reported, in the following formats by 7<sup>th</sup> Feb. 2013 positively. ## Note:- Reference regarding The Constitution (97th Amendment) Act, 2011-reg.

The Hon'ble High Court of Gujarat vide its order dated 22.04.2013 in the matter of WP (PIL) No. 166 of 2012 Rajendra N Shah versus Union of India & Anr. has struck down part IX B containing Articles 243ZH to 243ZT of the Constitution of India. Therefore, a Special Leave Petition Nos. 25266-67 of 2013 has been filed in the Hon'ble Supreme Court of India against the aforesaid order by the Government of India and the same is pending for hearing.
