ORDER

Hon'ble Delhi High Court in W.P. No. 669/2021- Sahara Credit Cooperative Society Ltd., W.P. No. 670/2021- Saharayn Universal Multipurpose Society Ltd., & W.P. No. 817/2021- Humara India Credit Cooperative Society Ltd., vs. Union of India has passed an Order dated 22.03.2022. In compliance of the order, claims received in the office of the Central Registrar of Cooperative Societies (CRCS) and through court intervention applications are being sent to the Nodal Officer/Managing Director of the societies concerned for verification and settlement in batches after digitisation. This order is in respect of claims in the batch sent to **Saharayn Universal Multipurpose Society Ltd.**, hereinafter, referred to as the Society on 19.04.2022.

2. Whereas, the Batch was sent vide e-mail dated 19.04.2022 with a direction to reply within a week in the prescribed format after due verification. Since, the requisite details were not received in time, a reminder letter was sent on 27.04.2022 via e-mail to the designated nodal officer of the above society. As, no response was also received to the telephone calls made by this office, a meeting was convened on 29.04.2022 at 4 PM with the concerned Nodal Officer. Just before the meeting, a reply from the Society on the claims of the Batch was received with the following details:

- i. 95 claim records have been verified to be correct by the Society.
 - ii. 09 claims have been reportedly been settled by the Society.
3. Therefore, the Society is directed to take following action:
- i. In respect of above claims which have been verified but not paid by the Society, make all such payment within two weeks of this order as per the timelines stipulated by the Hon'ble High Court of Delhi in its order dated 22.03.2022. It is also directed to upload the proof of payment by the due date.
 - ii. In respect of claims where due amount is stated to have been paid, it is directed to upload all payment details within a week.
