ORDER

(Under Section 86 of the Multi-State Cooperative Societies Act, 2002)

Whereas, **Misal Multipurpose Cooperative Society Ltd.**, Godrej Water Side, Tower-2, 15th Floor, Office No.1505, 1506, 1507, Plot No.5, Block DP, Salt Lake, Sector-V, Kolkata-700091, West Bengal (Registration No. MSCS/CR/852/2013) (herein after referred as Society) is registered under the provisions of Multi-State Cooperative Societies Act, 2002 (herein after referred as Act) and Rules made thereunder.

2) Whereas, vide complaint dated 24.10.2013 received through the Registrar of cooperative Societies, Govt. of Agartala, it was brought to the notice of this Authority that the Society had violated provisions of its registered Bye-laws. Therefore, the Society was called for personal hearing on 05.02.2014 to appear before the Central Registrar of Cooperative Societies (CRCS) to explain the matter along with requested documents through its Chairman/Chief Executive personally. At the time of hearing, it was found that the Society had forged and fabricated its registered bye- laws. Accordingly, the original registration certificate & bye-laws of the Society were seized and the registration of the Society was kept in abeyance. The matter was also reported to the S.H.O., PS- Parliament Street, New Delhi.

3) Whereas, further personal hearings were fixed on 15.07.2016 & 02.08.2016 before the Central Registrar of cooperative societies to furnish the comments on admission of more nominal members and to explain the status of its working, but nobody appeared on behalf of the Society in these hearings.

4) Whereas, sufficient opportunities were given to the Society, but the Chairman/Chief Executive of the Society did not appear before the Central Registrar of Cooperative Societies. Apparently, the Society was not functioning as per provision of the MSCS Act, 2002 and therefore, it was decided to initiate winding up process of the Society under the provision of the Act. Accordingly, a Notice dated 13.02.2017 was issued and objections to initiate winding up of the Society, if any, within 15 days from the date of Notice were called, but nothing was heard from the Society in this regard.

5) Whereas, this office vide letters dated 10.02.2017, 18.12.2017, 02.02.2018, 02.12.2018, 14.06.2019, 07.02.2020, 12.02.2020 and 27.03.2023 including various telephonic conversation and meetings requested Registrar of Cooperative Societies, Govt. of West Bengal to provide a list of officers (ex-officio/designation basis), who could be considered for appointment as liquidator of the Society.

6) Whereas, the office of Registrar of Cooperative Societies, Government of West Bengal vide letter No. DCOOP-28099/1/2020-L AND R CELL- DCOOP - 1/424560/2023 dated 08.08.2023 has recommended Assistant Registrar of Cooperative Societies, Kolkata Range to be appointed as liquidator in the Society.

7) Now, therefore, after careful consideration of the facts, I, Vijay Kumar, Central Registrar of Cooperative Societies in exercise of the powers conferred under Section 86 of the Act, order winding up of Misal Multipurpose Cooperative Society Ltd., Godrej Water Side, Tower-2,15th Floor, Office No.1505, 1506, 1507, Plot No.5, Block DP, Salt Lake, Sector-V, Kolkata-700091, West Bengal and hereby appoint Assistant Registrar of Cooperative Societies, Kolkata Range as liquidator of the Society under the provisions of Section 89 (1) of the Act until further orders with the direction to take further necessary action as per the provisions of MSCS Act, 2002 & rules made thereunder.

8) The Liquidator shall finalize the liquidation proceeding to wind up the Society and shall also submit the status report showing the progress made in liquidation of the Society to this office on quarterly basis.
