ORDER

(Under Section 86 of the Multi-State Cooperative Societies Act, 2002)

Whereas, **Khusi Credit Cooperative Society Ltd., Plot No. 17, Opposite O.S. Motors, Near Bombay Motors Circle, Upper Chopasni Road, Jodhpur, Rajasthan 342001** (Regn No.: MSCS/CR/389/2011) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies Act, 2002 and Rules made thereunder (hereinafter referred as Act)

2) The Registrar of Cooperative Societies, Govt. of Rajasthan vide letter No. F.15(19) savira/credit/writ petition/2023/3331 dated 03.02.2023 has reported that Society is not present at its registered address. Besides this, it is observed that the Society has not filed its mandatory Annual Returns to this Authority. The Society was requested to furnish its explanation vide letter dated 11.05.2023, but no response was received in this Office from the Society.

3) To provide a final opportunity to the Society, a Notice dated 15.06.2023 was issued for seeking objections to initiate winding up of the Society, if any, within 15 days from the date of uploading of Notice on the Official Website i.e. www.msos.dac.gov.in. But nothing has been heard from the Society. Since, sufficient opportunities have been given to the Society and no response is received. Therefore, it is clear that the Society is not functioning at its registered address in accordance with the provisions of the MSCS Act, and Rules made thereunder and it was decided to initiate winding up of the Society under the provision of the Act and Rules made thereunder.

4) Now, therefore, after careful consideration of the facts, I, Vijay Kumar, Central Registrar of Cooperative Societies in exercise of the powers conferred under Section 86 of the Act, order winding up of "Khusi Credit Cooperative Society Ltd., Plot No. 17, Opposite O.S. Motors, Near Bombay Motors Circle, Upper Chopasni Road, Jodhpur, Rajasthan 342001 and hereby appoint Deputy Registrar, Cooperative Societies, Jodhpur (City), Rajasthan as liquidator of the Society under the provisions of Section 89(1) of the Act to take further necessary action as per the provisions of Multi-State Cooperative Societies Act, 2002 and Rules made thereunder.

4) The liquidator shall also submit the status report showing the progress made in liquidation of the Society on quarterly basis to this Office.
