Sir,

I am directed to refer to Assistant Registrar Cooperative Society, Karjat, Ahmednagar letter dated Nil submitting therewith comprehensive report of Returning officer on the election of members of Board of Directors of Lakshyavedh Multispeciality Cooperative Hospital and Research Center Limited, Ahmednagar.

2) In this context, it is intimated that as per the provisions of the Multi-State Cooperative Societies (Amendment) Act, 2023 (notified on 03.08.2023), the Cooperative Election Authority established by the Central Government shall only be responsible for conducting the election w.e.f 03.08.2023. Accordingly, the Authority shall discharge following functions:

- a. Conduct the elections of the multi-State Cooperative Society;
- b. Supervise, direct and control the matters relating to preparation of electoral rolls; and
- c. Such other functions as may be prescribed

3) **In view of above, the election conducted by any other Authority other than CEA, is not valid.**

4) Therefore, it is directed to take appropriate action as per the provisions of Multi-State Cooperative Societies (Amendment) Act, 2023. The Board of Directors must urgently send a requisition through CRCS Portal to the Cooperative Election Authority established for the purpose of conduct of election. Copy of this Office Circular No. L-11012/7/2023-L&M dated 21.11.2023 is enclosed herewith for detail reference.

CIRCULAR

The Co-operative Election Authority has been established under Section 45(1) of the Multi-State Cooperative Societies Act, 2002 vide order dated 20.11.2023.

2. As per Rule 19(H)(1) of the Multi-State Cooperative Societies (Amendment) Rules, 2023, the Chairman and the Chief Executive of the multi-State co-operative society shall inform the Authority at least six months before the expiry of the term of the board, to conduct elections within time and a copy of the information shall also be sent to the Central Registrar. Steps to submit election request through CRCS Portal are as follows:

- i. Log in to the CRCS portal using your society's credentials.
- ii. Navigate to the "Election Request" section.
- iii. Complete the required details accurately.
- iv. Attach necessary documents as specified in the portal.
- v. Submit the signed request electronically through the portal.
