Sub: To conduct elections of members of Board of Directors of Stars Multipurpose Cooperative Society Ltd.– regarding.

Sir,

I am directed to refer to your letter dated 29.08.2023 on the subject mentioned above and to say that this election process of the Society is not in consonance with provisions of the MSCS Act and society has to follow the provisions of the Multi-State Cooperative Societies (Amendment) Act, 2023.

2) As per the provisions of the Multi-State Cooperative Societies (Amendment) Act, 2023, the Cooperative Election Authority established by the Central Government shall only be responsible for conducting the election w.e.f 03.08.2023. Accordingly, the Authority shall discharge following functions:

- a. Conduct the elections of the multi-State Cooperative Society;
- b. Supervise, direct and control the matters relating to preparation of electoral rolls; and
- c. Such other functions as may be prescribed

3) Therefore, it is directed to take appropriate action as per the provisions of Multi-State Cooperative Societies (Amendment) Act, 2023. The Board of Directors must urgently send a requisition through CRCS portal to the Cooperative Election Authority established for the purpose of conduct of election. Copy of this Office Circular No. L-11012/7/2023-L&M dated 21.11.2023 is enclosed herewith for detail reference.
