Mohan Kripa Credit Cooperative Society Ltd., SKSS BHAROSA, Ground Floor, SKSS Plaza, Main Road, Gandhi Colony, Jaisalmer-345001 (Registration No. MSCS/CR/466/2011) (hereinafter referred to as Society) is registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 (hereinafter referred to as Act) and Rules framed thereunder.

2) The Registrar of Cooperative Societies, Government of Rajasthan vide letter No. F.15(19)savira/k.thri.so/vigilance committee/2021/part-2 dated 06.04.2023 submitted an inspection report of Society u/s 108 of Multi-State Cooperative Societies Act, 2002 and reported that no such office of the Society is found operating at its registered address.

3) Besides above, the above Society has not submitted its mandatory annual returns u/s 120 of the Act to this office.

4) Accordingly, a Show Cause Notice dated 17.10.2023 followed by a subsequent reminder dated 25.01.2024 were issued to the Chairman/Chief Executive of Society for seeking an explanation, but the envelopes containing the notices returned undelivered with remarks 'Left without notice'. These Notices were also served through CRCS Portal, but nothing heard from the Society.

5) In view of the above, it appears that the Society is not functioning at its registered address as per the provisions of the MSCS Act, Rules and its approved bye-laws and accordingly, it has been decided to initiate winding up process of the Society under the provisions of the MSCS (Amendment) Act, 2023 and Rules framed thereunder. In case of any objection, the same may be brought to the notice of this Authority within 15 days from the date of uploading of this Notice on the Official Website i.e. crcs.gov.in, failing which it will be presumed that the Society has nothing to say in the matter and action would be initiated for winding up of the Society under the provisions of the MSCS (Amendment) Act, 2002 and Rules framed thereunder.
