The Registrar of Cooperative Societies, Government of Rajasthan, recommended to put society under liquidation as per the MSCS Act and Rules
- 3) Besides above, the above Society has not submitted its mandatory annual returns u/s 120 of the Act for the last three years to this office.
- 4) Accordingly, a Show Cause Notice dated 12.10.2023 followed by a subsequent reminder dated 04.01.2024 were issued to the Chairman/Chief Executive of Society for seeking an explanation, but till date no reply in this context is received in this office.
- 5) Therefore, it appears that Society is not functioning at its registered address as per the provisions of the Act, Rules and its approved bye-laws and accordingly, it has been decided to initiate winding up process of the Society under the provisions of the MSCS Act, 2002 and Rules made thereunder. In case of any objection, the same may be brought to the notice of this Authority within 15 days from the date of uploading of this Notice on the Official website i.e. crcs.gov.in, failing which it will be held that the Society has nothing to say in the matter and action would be initiated for winding up of the Society under the provisions of the MSCS Act, 2002 and Rules framed thereunder.
