#### ORDER

[Under sub-section (4) of Section 84 of the Multi State Cooperative Societies Act, 2002]

Whereas, All India Handloom Fabrics Marketing Cooperative Society Ltd., New Delhi is a Federation registered under the provisions of Multi State Cooperative Societies (MSCS) Act, 2002 and rules made there under. **Purvanchal Hathkargha Sahakari Sangh Ltd.** is member of the Federation, is registered under the Uttar Pradesh Cooperative Society Act, 1965.

- 2. Whereas, the Arbitration Petition **No. 75 of 2024** filed on 15.01.2024 by Purvanchal Hathkargha Sahakari Sangh Ltd. against All India Handloom Fabrics Marketing Cooperative Society Ltd. and another in the High Court of Delhi at New Delhi. The Hon'ble High Court of Delhi vide its order dated 24.04.2024 (**order released on 08.05.2024**) directed the Central Registrar of Cooperative Societies (CRCS) to appoint an Arbitrator **within three weeks** and inform all parties.
- 3. In view of the Arbitration Petition No.75 of 2024, RCS, Govt. of NCT of Delhi was requested to provide this office, a name for appointment of Arbitrator to settle the dispute regarding the clearance of outstanding bills. In response, RCS, Govt. of NCT of Delhi has recommended the name of Dr. T Philip Thanglianmang, IAS (Retired), 51, Delhi Govt. Officers Flats, Greater Kailash-1, New Delhi-110048.
- 4. Now, therefore, after careful consideration in compliance of the Hon'ble High Court Order dated 24.04.2024, **Dr. T Philip Thanglianmang, IAS (Retired)** is appointed as Arbitrator to settle the dispute between concerned parties.

- 5. The arbitration fee in the matter may be fixed as per Arbitration & Conciliation Act, 1996 and the arbitration proceedings may be concluded within prescribed time limit of the Act.
- 6. This issues with the approval of the Central Registrar of Cooperative Societies.
