"Vikas Cooperative Credit Society Ltd.", 222, Bhaskar Mohalla, Pokran, Jaisalmer, Rajasthan (MSCS/CR/742/2013)" (hereinafter referred to as Society) is registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 (hereinafter referred to as Act) and Rules framed thereunder.

2) The Registrar of Cooperative Societies, Government of Rajasthan vide letter No. F.15(19)savira/k.thri.so/vigilance committee/2021/part-2 dated 06.04.2023 submitted an inspection report of Society u/s 108 of Multi-State Cooperative Societies Act, 2002 and reported that no such office of the Society is found operating at its registered address. The Registrar of Cooperative Societies, Government of Rajasthan, recommended to put Society under liquidation as per the MSCS Act, 2002 and Rules framed thereunder.

3) Further, the above Society has not submitted its mandatory annual returns u/s 120 of the Act to this office.

4) Accordingly, a Show Cause Notice dated 17.10.2023 followed by a subsequent reminder dated 10.01.2024 were issued to the Chairman/Chief Executive of Society for providing their explanation through Speed Post as well as CRCS portal, but till date no reply has been received from the Society in this office. Besides this envelopes containing the notices returned undelivered to this Office with remarks 'there is no Society with this name at this written address'.

5) Therefore, it appears that Society is not functioning at its registered address as per the provisions of the Act, Rules and its approved bye-laws and accordingly, it has been decided to initiate winding up process of the Society under the provisions of the MSCS Act, 2002 and Rules made thereunder. In case of any objection, the same may be brought to the notice of this Authority within 15 days from the date of uploading of this Notice on the CRCS portal i.e. crcs.gov.in, failing which it will be held that the Society has nothing to say in the matter and action would be initiated for winding up of the Society under the provisions of the MSCS Act, 2002 and Rules framed thereunder.
