**ORDER**

(Under section 86 of the Multi-State Co-operative Societies Act, 2002)

Whereas, **Indian Tourism Cooperative Ltd., 12, Sapna Community Centre, East of Kailash, New Delhi-110065** (hereinafter referred to as the society), is a multi-State cooperative society registered under the provisions of Multi-State Co-operative Societies Act, 2002 (herein after called as Act).

2. Vide Order of even number dated 06.02.2013 (copy enclosed), Shri V. K. Verma, Director (Cooperation), Department of Agriculture & Cooperation, Ministry of Agriculture was appointed as the liquidator of the Society under the provisions of the Act and rules made thereunder. Shri Verma vide note dated 25.02.2016 had shown his inability to work as the liquidator of the Society due to preoccupied with some other Official work.

3. Earlier, the matter for appointment of liquidator in the multi-State cooperative societies of Delhi was discussed with the Divisional Commissioner and Registrar of Cooperative Societies, Govt. of NCT of Delhi and it has been decided to appoint the Deputy Commissioner (ex-officio/designation basis) of the district concerned as liquidator of the Society located in his jurisdiction.

4. Therefore, after careful consideration of the facts, I, Anand Kumar Jha, Central Registrar of Cooperative Societies, in exercise of powers conferred under Section 89(1) of the Act appoint Deputy Commissioner, District-South as liquidator of the Society until further orders in place of Shri Verma to take further necessary action as per the provisions of MSCS Act, 2002 & rules made thereunder.

5. The liquidator will submit status report showing the progress made in liquidation work of the Society on quarterly basis to this office.
