ORDER

(Under Section 86 of the Multi-State Co-operative Societies Act, 2002)

Whereas vide this Office Order No. R-11017/18/2014-L&M (Pt.-I) dated 12.01.2021, Smt. Esther Rani John, Deputy Registrar of Cooperative Societies, Charminar Division, 4th Floor, Gruhakalpa Building, Nampally, Hyderabad-500001, Telangana O/o Commissioner for Cooperation & Registrar of Cooperative Society was appointed as liquidator to wind up the Grahak Bazar Cooperative Societies Ltd., 202, G Block, 2-21075/2, Bagh Amberpet, Hyderabad under the provisions of the Multi State Cooperative Societies (MSCS) Act, 2002 and rules made thereunder.

2. Registrar of Cooperative Societies, Govt. of Telangana, Hyderabad vide letter No. COOPN/AUDT/MSCS/5/2023-audit dated 23.03.2024 has forwarded a status report of liquidation work of the Society as submitted by Smt. Esther Rani John, liquidator and informed that Smt. Esther Rani John has been promoted as SCDR and currently under the deputation to Telangana State Industrial Corporation Ltd, Industries & Commerce Department, Telangana State. Further, requested to appoint liquidator by post/designation name i.e., Deputy Registrar of Cooperative Societies, Charminar Division.

Therefore, after careful consideration of the facts, I, Anand Kumar Jha, Central Registrar of Cooperative Societies, in exercise of powers conferred under Section 89(1) of the MSCS Act, 2002 appoint Deputy Registrar of Cooperative Societies, Charminar Division, O/o the Registrar of Cooperative Societies, Government of Telangana as liquidator of Grahak Bazar Cooperative Societies Ltd., 202, G Block, 2-21075/2, Bagh Amberpet, Hyderabad till further orders.

4. The Liquidator shall also submit the status report showing the progress made in liquidation of the society to this Office on quarterly basis.
