ORDER

[Under sub-section (4) of Section 84 of the Multi State Cooperative Societies Act, 2002]


Whereas, the Applicant, Indian Farmers Fertilizers Cooperative Limited (IFFCO), New Delhi is a Federation registered under the provisions of Multi State Cooperative Societies (MSCS) Act, 2002 and rules made there under and M/S Chintamani Taluk Agriculture Produce Cooperative marketing society limited is a member of the Federation (hereby referred as Respondent).

2. Whereas, the request for arbitration dated 07.02.2023 was received in the office of CRCS, for settlement of dispute/claim of IFFCO with the Respondent. In view of this, RCS, Govt. of NCT of Delhi was requested to suggest name of person to be appointed as arbitrator in the said case. In response, RCS, Govt. of NCT of Delhi has recommended the name of **Dr. T Philip Thanglianmang, IAS (Retired), 51, Delhi Govt. Officers Flats, Greater Kailash-1, New Delhi-110048.**

4. Now, therefore, after careful consideration **Dr. T Philip Thanglianmang, IAS (Retired)** is appointed as Arbitrator to settle the dispute between concerned parties.

5. The arbitration fee in the matter may be fixed as per Arbitration & Conciliation Act, 1996 and the arbitration proceedings may be concluded within prescribed time limit of the Act.
