ORDER

(Under Section 86 of the Multi-State Cooperative Societies Act, 2002)

Whereas, "**Vikas Cooperative Credit Society Ltd.**", 222, Bhaskar Mohalla, Pokran, Jaisalmer, Rajasthan (MSCS/CR/742/2013)" (hereinafter referred to as Society) is registered under the provisions of Multi-State Cooperative Societies Act, 2002 (hereinafter referred to as Act) and Rules framed thereunder.

2) The Registrar of Cooperative Societies, Government of Rajasthan vide letter No. F.15(19)savira/k.thri.so/vigilance committee/2021/part-2 dated 06.04.2023 submitted an inspection report of Society u/s 108 of Multi-State Cooperative Societies Act, 2002 and reported that no such office of the Society is found working at its registered address. The Registrar of Cooperative Societies, Government of Rajasthan, recommended to put society under liquidation as per the MSCS Act and Rules

3) Society has also not filed its annual returns mandatory u/s 120 of the Act.

4) A Show Cause Notice dated 17.10.2023 followed by a subsequent reminder dated 10.01.2024 were issued to Chairman/Chief Executive of Society for explanation, but till date no reply from the Society is received in this office in this context. Besides this envelopes containing the reminder returned undelivered to this Office with remarks 'there is no Society with this name at this written address/left'.

5) It appeared that Society is not functioning at its registered address as per the provisions of the Act, Rules and its approved bye-laws and it has been decided to initiate winding up process of the Society under the provisions of the MSCS Act, 2002 and Rules made thereunder. Accordingly, a Notice dated 16.05.2024 was issued for seeking objection from the Society on the same. The Notice was also uploaded on Official Website i.e. crcs.gov.in, but no reply from the Society is received in this Office till date. The envelope containing the Notice, returned undelivered to this Office.



The Registrar of Cooperative Societies, Govt. of Rajasthan, Jaipur vide

letter dated 07.09.2021 has already provided a list of Officers by Post/Designation of the Cooperative Department, Govt. of Rajasthan for appointment as liquidator in the multi-State cooperative societies.

7) Now therefore, after careful consideration of the facts, I, Anand Kumar Jha, Central Registrar of Cooperative Societies in exercise of the powers conferred under Section 86 of the Act, order winding up of, "Vikas Cooperative Credit Society Ltd.", 222, Bhaskar Mohalla, Pokran, Jaisalmer, Rajasthan and hereby appoint Deputy Registrar of Cooperative Societies, Jaisalmer, Office of the Registrar of Cooperative Societies, Government of Rajasthan as Liquidator of the Society under the provisions of Section 89 (1) of the Act until further orders with the direction to take further necessary action as per the provisions of Act & rules made thereunder.

8) The Liquidator shall finalize the liquidation proceeding to wind up the Society and shall also submit the status report showing the progress made in liquidation of the Society to this office on quarterly basis.
