Golden Credit Cooperative Society Ltd, 5, T.M. Colony, Behind Pradeep Hospital, Bharatpur, Rajasthan-321001 (Regn No.: MSCS/CR/731/2013) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 and Rules made thereunder (hereinafter referred as Act).

2. The Registrar of Cooperative Societies, Government of Rajasthan vide letter No. F.15(19) Savira/k.thri.so/vigilance committee/2021/part-2 dated 06.04.2023 submitted an inspection report of Golden Credit Cooperative Society Ltd., 5, T.M. Colony, Behind Pradeep Hospital, Bharatpur, Rajasthan-321001 (MSCS/CR/731/2013)" u/s 108 of Multi-State Cooperative Societies Act, 2002 and reported that no such office of the Society is found operating at its registered address.

2. Also, the Society has not been filing its mandatory Annual returns u/s 120 of the MSCS Act, 2002 to this authority since inception.

3. A Show Cause Notice dated 16.10.2023 was issued to the Society for furnishing its explanation in the matter, but no reply was received from the Society with in stipulated time. Thereafter, a reminder dated 04.01.2024 was also issued to the Society, but the same was returned undelivered to this Office with remarks "left".

4. Therefore, it appears that the Society is not functioning at its registered address as per the provisions of the MSCS Act, 2002, Rules framed thereunder and its approved Bye-laws. Accordingly, it has been decided to initiate winding up process of the Society under the provisions of the MSCS Act, 2002 and Rules made thereunder. In case of any objection, the same may be brought to the Notice of this Authority within 15 days from the date of uploading this Notice on the official website i.e. www.msos.dac.gov, failing which it will be held that the Society has
