ORDER

(Under sub-section (2) of Section 40 of the Multi-State Cooperative Societies Act, 2002)

Whereas, State Bank of India Employee's (Charles Coutto) Cooperative Society Ltd., Plot (House) No. 380, Behind Punjab National Bank, Near Orange City School, Mohan Nagar, Nagpur, Maharashtra-440001 (hereinafter referred as Society) is a Multi-State Cooperative Society registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 and rules made thereunder.

2. A letter dated 10.10.2023 was received from Manager, State Bank of India Employee's (Charles Coutto) Cooperative Society Ltd., informing therein that out of 17 Board of Directors of the society, 4 have been retired, 4 have been removed and 8 have resigned from the society. Presently, Society has only one director. Due to which, Society cannot pay the expenses, rent and Salary of its employees as all the powers of operating accounts of society were with the President and Joint Secretary of Society who have been retired.

3. Vide letter dated 06.11.2023, Commissioner for Cooperation and Registrar of Cooperative Societies, Govt. of Maharashtra was requested to conducting an inspection of the Societyu/s 108 of the MSCS Act, 2002. The Commissioner for Cooperation and Registrar of Cooperative Societies, Govt. of Maharashtra vide letter No. CR-5/Cr.Soc./MSCS/ SBI Emp. Nagpur/ Insp. Report/867/2024 dated 11.03.2024 (copy enclosed) submitted an inspection report of the Society and reported that due to retirement of some board members and resignation given by the other board members, the entire work of Society is stopped due to non-availability of authorised signatory.

4. Thereafter, to resolve the issue, the Commissioner for Cooperation and Registrar of Cooperative Societies, Govt. of Maharashtra was requested to provide name of an Officer who could be authorised to call Special General Meeting of General Body of the Society. vide letter dated 16.07.2024, the Commissioner for Cooperation and Registrar of Cooperative Societies, Govt. of Maharashtra has recommended the name of Shri Dinesh Chandel, Divisional Deputy Registrar, Cooperative Societies, Nagpur as the Authorised Officer for calling Special General

Meeting of General Body of the Society.

5. Now, therefore, after careful consideration of the facts, I, Anand Kumar Jha, Central Registrar of Cooperative Societies, in exercise of the power conferred under Section 40(2) of the MSCS Act, 2002 hereby appoints Shri Dinesh Chandel, Divisional Deputy Registrar, Cooperative Societies, Nagpur as the Authorised Officer for calling Special General Meeting of General Body of State Bank of India Employee's (Charles Coutto) Cooperative Society Ltd., Plot (House) No. 380, Behind Punjab National Bank, Near Orange City School, Mohan Nagar, Nagpur, Maharashtra-440001 under the provisions of MSCS Act, 2002 and rules framed thereunder to resolve the issues in the Society. Expenditure incurred in calling above Special General Meeting of General Body of the Society, shall be paid out of the funds of the Society.
