**ORDER**

[Under sub-section (4) of Section 84 of the Multi State Cooperative Societies Act, 2002]

In exercise of powers conferred under sub-section (4) of section 84 of the MSCS Act, 2002, I Anand Kumar Jha, Central Registrar of Cooperative Societies, hereby appoint **Sh. S.K Srivastava, IAS (Retired)** as Arbitrator to settle the dispute of election of Board of Directors between Sh. Ramdas P. Sandhe and Ors., and National Federation of Fishers Cooperatives Ltd.(FISHCOPFED) as per the provisions of Arbitration & Conciliation Act, 1996 read with Section 84 of the Multi State Cooperative Societies Act, 2002.

2. It is pointed out that as per sub -section 5 of section 84 of the MSCS Act, 2002 – "Save as otherwise provided under this Act, the provisions of the Arbitration and Conciliation Act, 1996 (26 of 1996) shall apply to all arbitration under this Act as if the proceedings for arbitration were referred for settlement or decision under the provisions of the Arbitration & Conciliation Act, 1996". The fee and other expenses of the Arbitrator shall be governed by the provisions of the Arbitration & Conciliation Act, 1996.

3. The dispute has to be settled by the Arbitrator within the time limit prescribed in the Arbitration & Conciliation Act, 1996.
