ORDER

(under section 86 of the Multi-State Co-operative Societies Act, 2002)

Whereas, Jatrophia Growers & Bio-Fuel Development Co-operative Ltd., Plot No. 29-B, Journalist Colony, Jubilee Hills, Hyderabad-500033 (hereinafter referred to as the society) is a multi-State cooperative society registered under the provisions of Multi-State Co-operative Societies Act, 2002 (herein after called as Act).

2. Vide this Office's Order dated 06.06.2024, Deputy Registrar/ Divisional Cooperative Officer, Hyderabad (West) Division, Ranga Reddy District, O/o Commissioner for Cooperation & Registrar of Cooperative Societies, Government of Telangana was appointed as the liquidator of the Society replacing Shri K. Narendra Reddy, DLCO, Hyderabad (West), O/o Commissioner & Registrar of Cooperative Societies, Government of Telangana, under the provisions of the MSCS Act, 2002 and rules made thereunder.

3. Now, vide letter No. COOPN-AUDIT/MSCS/5/2023-audit dated 31.07.2024, Director for Cooperation & Registrar of Cooperative Societies, Telangana, Hyderabad has informed that currently the post of Deputy Registrar/ Divisional Coop. Officer (West) Division, Ranga Reddy District is not in existence and further provided a list of Officers of the Cooperative Department, Govt. of Telangana working in the jurisdiction of Hyderabad for appointment as liquidator in the Society.

4. Therefore, after careful consideration of the facts, I, Anand Kumar Jha, Central Registrar of Cooperative Societies, hereby appoint Joint Registrar/ District Cooperative Officer, Hyderabad as liquidator of the Society until further orders in place of Deputy Registrar/ Divisional Cooperative Officer, Hyderabad (West) Division, Ranga Reddy District to take further necessary for liquidation of the Society as per the provisions of MSCS Act, 2002 & rules made thereunder.

5. Shri Reddy shall hand over the charge of the liquidation work of the Society to the Joint Registrar/ District Cooperative Officer, Hyderabad with immediate effect and apprise him of the liquidation proceedings undertaken by him so far. The Liquidator is requested to expedite the liquidation proceedings and submit status report showing the progress made in liquidation work of the Society on quarterly

basis to this office.
