**ORDER**

(Under section 86 of the Multi-State Co-operative Societies Act, 2002)

Whereas, **Indian Tourism Cooperative Ltd., 12, Sapna Community Centre, East of Kailash, New Delhi-110065** (hereinafter referred to as the society), is a multi-State cooperative society registered under the provisions of Multi-State Co-operative Societies Act, 2002 (herein after called as Act).

2. Vide this Office Order of even number dated 24.05.2024, Deputy Commissioner, District- South, Government of NCT of Delhi was appointed as the liquidator of the Society under the provisions of the Act and rules made thereunder.

3. District Magistrate (South), Government of NCT of Delhi vide letter No. PA/SDM (HQ)/ (2022)/2024/551 dated 02.08.2024 has informed that the registered address of the Society falls in the jurisdiction of District (South-East) and requested to direct concerned District in the matter.

4. Therefore, after careful consideration of the facts, I, Rabindra Kumar Agarwal, Central Registrar of Cooperative Societies, in exercise of powers conferred under Section 89(1) of the Act appoint Deputy Commissioner, District-South-East as liquidator of the Society until further orders in place of Deputy Commissioner, District- South to take further necessary action as per the provisions of MSCS Act, 2002 & rules made thereunder.

5. The liquidator of the Society will submit status report showing the progress made in liquidation work of the Society on quarterly basis to this office.
