<u>ORDER</u>

Whereas, in exercise of the powers conferred by section 45K (1) of the Multi State Co-operative Societies (MSCS), Act2002 (as amended from time to time) read with rule 19F(a) of the MSCS Rules,2002, the Co-operative Election Authority (CEA)appointed DistrictMagistrate, Patna, Bihar, as Returning Officer (RO) on 21.12.2023 for conduct of Elections of the Bihar State Cooperative MarketingUnion Ltd (BISCOMAUM) and enclosing there with theElection programme(14.05.2024 to 11.06.2024). The election program was later on revised on the request of RO from 18.06.2024 to 11.07.2024as the earlier dates were overlapping with General Lok Sabha Elections, 2024in Patna.

Whereas, vide letter no-LIV/03/2024/1479 dated 2.7.2024, the Returning Officer requested theCooperative Election Authority to cancel the elections of the BISCOMAN citing reasons inter-alia, that the Managing Director (MD) of the BISCOMAUNhad not shared accurate information and records regarding proposed amendment of Bye-Laws no. 27 purporting to increase numbers of elected Directors from 17 to 21. It was also stated by the RO that election process had been commenced to elect 21 Board of Directors of BISCOMAUN. However, the proposal to increase number of directors' and the amendment in Bye-Law no. 27, was rejected by the competent authority i.e. the Central Registrar of Cooperative Societies (CRCS). Therefore, RO recommended that continuation of elections which werebased onunapproved Bye-Laws will not be as per theMSCS Act, 2002 (as amended from time to time)and Rules framed there under.

Whereas, considering the request of the Returning Officer, the CEA vide its letter no. CEA/12011/36/2024 dated 10.07.2024 postponed the election process and later decided to seek a detailed report on the matter from RO vide letter no. CEA/12011/36/2024dated 12.07.2024.

Whereas, the report of the RO sentvide letter no. LIV-03/2024/1632/ Patna, dated 19.07.2024 in response of CEA/12011/36/2024 dated 12.07.2024 asking for detailed report, inter-alia indicated aboutlack of transparency in preparation of delegate list, delay in

disclosure of eligibility criteria for election of a delegate. RO also reiterated his recommendations for cancelation of elections of BISCOMAUNin the interest of conducting free, fair & transparent elections.

The Cooperative Election Authority consideredall available material with it, Report of the Returning officer dated 19.07.2024 and various provisions of the MSCS Act & Rules (as amended from time to time) and came to the conclusion that the process and attempt to conduct elections have failed as MD/ Board of Director have not extended necessary assistance as required under Section 123 of the MSCS Act and as per provision of Section 45 of the MSCS Act. Now, elections of the BISCOMAUN cannot be held as per the program issued and therefore, the Authority decided to cancel the elections process for Board of Directors and Office Bearers of BISCOMAUN.
