**ORDER**

(Under Section 86 of the Multi-State Cooperative Societies Act, 2002)

Whereas, **Golden Credit Cooperative Society Ltd, 5, T.M. Colony, Behind Pradeep Hospital, Bharatpur, Rajasthan-321001** (Regn No.: MSCS/CR/731/2013) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 and Rules made thereunder (hereinafter referred as Act).

2. The Registrar of Cooperative Societies, Government of Rajasthan vide letter No. F15(19) Savira/k.thri.so/vigilance committee/2021/part-2 dated 06.04.2023 submitted an inspection report of Golden Credit Cooperative Society Ltd., 5, T.M. Colony, Behind Pradeep Hospital, Bharatpur, Rajasthan-321001 (MSCS/ CR/731/2013)" u/s 108 of Multi-State Cooperative Societies Act, 2002 and reported that no such office of the Society is found operating at its registered address. Besides this, it is observed that the Society has not been filing its mandatory Annual returns u/s 120 of the MSCS Act, 2002 to this authority since inception.

3. A Show Cause Notice dated 16.10.2023 was issued to the Society for furnishing its explanation in the matter, but no reply was received from the Society within stipulated time. Thereafter, a reminder dated 04.01.2024 was also issued to the Society, but the same was returned undelivered to this Office with remarks "left".

4. To provide a final opportunity to the Society, a Notice dated 23.07.2024 was issued for seeking objections to initiate winding up of the Society, if any, within 15 days from the date of uploading of Notice on the Official Website i.e., [www.crcs.gov.in](http://www.crcs.gov.in). But no reply was received from the Society. Since, sufficient opportunities have been given to the Society and no reply/objections has been received from the Society, therefore, it appears that the Society is not functioning at its registered address in accordance with the provisions of the MSCS Act, and Rules made thereunder and it is decided to initiate winding up of the Society under the provision of the Act and Rules made thereunder.

5. Now, therefore, after careful consideration of the facts, I, Rabindra Kumar Agarwal, Central Registrar of Cooperative Societies in exercise of the powers conferred under Section 86 of the Act, order winding up of "Golden Credit Cooperative Society Ltd, 5, T.M. Colony, Behind Pradeep Hospital, Bharatpur, Rajasthan-321001" and hereby



appoint Deputy Registrar, Cooperative Societies, Bharatpur, Govt. of Rajasthan as liquidator of the Society under the provisions of Multi-State Cooperative Societies Act, 2002 and Rules framed thereunder.

6. The liquidator shall also submit status report showing progress made in liquidation of the Society on quarterly basis to this Office.
