## ORDER

[Under sub-section (4) of Section 84 of the Multi State Cooperative Societies Act, 2002]

Whereas, All India Handloom Fabrics Marketing Cooperative Society Ltd., New Delhi is a Federation registered under the provisions of Multi State Cooperative Societies (MSCS) Act, 2002 and rules made there under. Appolo Handloom Manufacturing Cooperative Society Ltd., is registered under the Uttar Pradesh Cooperative Society Act, 1965, is member of the Federation.

- 2. Whereas, the Arbitration Petition **No. 1261 of 2023** filed on 06.12.2023 by Appolo Handloom Manufacturing Cooperative Society Ltd. against All India Handloom Fabrics Marketing Cooperative Society Ltd. and others in the High Court of Delhi at New Delhi.
