2. A discussion was held with the representatives of captioned society in the Office of CEA on 8.10.2024 regarding the clarification of Bye-Laws, as certain proposed amendment were rejected by the CRCS. The Society clarified that the election is being conducted on the basis of approved and registered Bye-laws (2019) by CRCS. The authority was satisfied with their clarification especially the due representations is being given to SC/ST and Women candidates in the election notification issued by Returning Officer (RO).

3. I am directed to say that the Election Programme of State Bank of India Employees (M S Patel) Cooperative Credit Society, Mumbai has been revised and further action to be taken on the following conditions

- i) Voting shall be made by all eligible voters/members.
- Nomination forms received during the period from 26 Sept
  2024 to 01 Oct 2024 shall remain valid subject to scrutiny as per revised programme. Such candidates need not file nominations again
- iii) two days additional be given for filling of nomination to eligible candidates, so as to provide equal opportunity for all candidates.
- The revised election programme from 10-11 Oct 2024 to 30 Oct 2024 is enclosed for conducting the remaining election of the society.
- 5. This issues with the approval of Cooperative Election Authority.
