**ORDER**

(Under section 86 of the Multi-State Co-operative Societies Act, 2002)

Whereas, vide this Office's Order of even No. dated 02.11.2023, Shri Kalyan Nag, M-18, 1<sup>st</sup> Floor, Chittranjan Park, New Delhi-110019 was appointed as Official Liquidator of The Cooperative Store Ltd. (Super Bazar), New Delhi under the provisions of the Multi State Cooperative Societies (MSCS) Act, 2002 and rules made thereunder.

2. The Department of Consumer Affairs (DoCA) being the Administrative Ministry of The Cooperation Store Ltd. (Super Bazar), New Delhi till further orders.
