ORDER

Whereas, Dadra Nagar Haveli Sahakari Khand Udyog Mandali, New Marketing Centre, Room No. 16 & 17, Dadra Nagar Haveli, Silvassa (Regn No.: MSCS Act/CR-8/89) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 and Rules made thereunder (hereinafter referred as Act).

- 2. A representation of Shri Brijesh Bhusara, Akhil Bhartiya Adivasi Vikas Parishad was received vide PMO ID dated 08.01.2024 regarding various irregularities in the functioning of Dadra Nagar Haveli Sahkari Khand Udyog Mandali. Vide letter dated 31.10.2023 (received on 16.02.2024) Managing Director (I/C), Dadra Nagar Haveli Sahkari Khand Udyog Mandali has also submitted a request for voluntarily winding up of the Society as per the provisions of Multi-State Cooperative Societies Act, 2002.
- 3. Vide letter dated 13.03.2024, the Office has sent representations of Shri Bhusara and Managing Director(I/C) of the Society, to the Registrar of Cooperative Societies, Govt. of UT of Dadra & Nagar Haveli and Daman & Diu with the request to conduct an inspection of the Society u/s 108 of the MSCS Act, 2002.
- 4. Assistant Registrar, Cooperative Societies, Dadra & Nagar Haveli and Daman & Diu, vide letter No. COOP/SUGAR MILL/DNH/2024/41 dated 12.07.2024, has submitted an inspection report of the Society conducted u/s 108 of the MSCS Act, 2002 and reported that Sugar Mill is not in operation and it is not viable and cannot be revived technically, financially as there is no feasibility and recommended for winding up of the Society.
- 5. The Society has also not submitted its mandatory annual returns required to be submitted u/s 120 of the MSCS Act, 2002 to this Office.
- 6. To provide a final opportunity to the Society, a Notice dated 14.08.2024 was issued for seeking objections to initiate process of winding up of the Society u/s 86 of MSCS Act, 2002, if any, within 15 days from the date of uploading of Notice on the Official Website i.e., www.crcs.gov.in. But no objection/reply was received from the Society.

7. Registrar of Cooperative Societies, Govt. of UT of Dadra & Nagar Haveli and Daman & Diu was requested vide letter dated 3.10.2024 to provide name of an Officer who be considered for appointment as liquidator in the Society.

- 8. Assistant Registrar, Cooperative Societies, Dadra & Nagar Haveli and Daman & Diu, vide letter No. COOP/SUGAR MILL/DNH/2024/84 dated 25.10.2024 has recommended Ms. Aarti Agarwal, Deputy Collector (General)-Cum-SDM, Daman, U.T of Dadra and Nagar Havel and Daman & Diu for appointment of liquidator in the Society.
- 9. Now, therefore, after careful consideration of the facts, I, Rabindra Kumar Agarwal, Central Registrar of Cooperative Societies in exercise of the powers conferred under Section 86 of the Act, order winding up of "Dadra Nagar Haveli Sahakari Khand Udyog Mandali, New Marketing Centre, Room No. 16 & 17, Dadra Nagar Haveli, Silvassa" and hereby appoint Ms. Aarti Agarwal, Deputy Collector (General)-Cum-SDM, Daman, U.T of Dadra and Nagar Havel and Daman & Diu, as Liquidator of the Society under the provisions of Section 89(1) of the Act until further orders to take further necessary action as per the provisions of Multi-State Cooperative Societies Act, 2002 and Rules made thereunder.
- 10. The liquidator shall also submit the status report showing the progress made in liquidation of the Society on quarterly basis to this Office.
