2. Members will cast vote as per section 31 and 32 of Multi-State Cooperative Society Act.

3. Further, in view of Rule 19(H)(2) of the MSCS Rule 2002 as amended in 2023 with MSCS Rule as 2023, the Election Program for conducting election of the aforementioned Society is enclosed for further necessary action. RO is requested to ensure the election is conducted as per the MSCS Act, 2002 and Rules framed there under.

4. After conduct of Elections of Board of Directors, the RO is mandated to submit the requisite details in Format 19 M (for members of the Board of Directors) under Rule 19 M for seeking prior approval of the Cooperative Election Authority

5. After conduct of Elections of Office Bearer (One Chairman & One Vice-Chairman), the RO shall submit the requisite details in Format 19 N for seeking **prior approval** of CEA before declaration of results.

6. Returning Officer shall ensure that the Society prominently displays the **List of Eligible Voters, Election Program and Final List of the Contesting Candidates**, and other related important documents on the website of the society for enabling free, fair and transparent elections.

7. Wide publicity to be given in the local News Paper & send SMS to members for participation/ holding of Elections in terms of provision of the MSCS Act and the rules framed there under. A press release about elections may be issued in local dailies.
8. Instructions for filling-up of the Format-M and N have been appended below the Format 'M' and 'N', the same should be scrupulously followed by the Returning Officer.
9. Further, It is also requested to provide the requisite details about basic pay of RO and ARO and other polling officers in the enclosed Performa to claim remuneration from the society in connection with discharge of duties for conduct of election as RO/ARO/Polling personnel etc.


