The programme will be organized by Centre for International Co-operation and Training in Agricultural Banking (CICTAB), Pune in collaboration with National Institute of Rural Development and Panchayati Raj (NIRDPR), Hyderabad, India

Objectives of the programme:

The overall objectives of the programme are:

- · To understand various dimensions and financial inclusion;
- To discuss the formal financial institutions and their current status and role towards financial inclusion;
