## **ORDER**

(Under Section 86 of the Multi-State Cooperative Societies Act, 2002)

Whereas, **EVOS Multistate Credit Cooperative Society Ltd., Plot No. 780, Sahid Nagar, Maharsi College Road, Bhubaneswar-751007, Odisha** (Regn No.: MSCS Act/CR/736/2013) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 and Rules made thereunder (hereinafter referred as Act).

2. A letter was received from Chairman, EVOS Multistate Credit Cooperative Society Ltd., Bhubaneswar, Odisha wherein it was informed that the Society has not commenced its operations and not accepted any deposit from public till date and closed its Bank Accounts and that the members of the Society in a special general meeting held on 15.11.2022 have decided for closure of the Society.

3. Vide letter dated 11.04.2023, reminder dated 03.11.2023 & DO letter dated 16.08.2024, Registrar of Cooperative Societies, Govt. of Odisha was requested to conduct inspection of the Society u/s 108 of the MSCS Act, 2002 by this office.

4. Vide letter No. RCSO-INSP-Others-0003-2024/15907 dated 21.09.2024, the Registrar of Cooperative Societies, Govt. of Odisha has submitted inspection report of Society conducted by Deputy Registrar of Cooperative Societies, Khordha Division u/s 108 of MSCS Act, 2002 and reported that Society is not functioning at its registered address.

5. To provide a final opportunity to the Society, a Notice dated 22.11.2024 was issued for seeking objection to initiate process of winding up of the Society, if any, within 15 days from the date of uploading of Notice on the Official Website i.e., [www.crcs.gov.in](http://www.crcs.gov.in). But no reply/objection was received from the Society. Therefore, it is decided to initiate winding up of the Society under the provision of the Act and Rules made thereunder.

6. Now, therefore, after careful consideration of the facts, I, Rabindra Kumar Agarwal, Central Registrar of Cooperative Societies in exercise of the powers conferred under Section 86 of the Act, order winding up of "EVOS Multistate Credit Cooperative Society Ltd., Plot No. 780, Sahid Nagar, Maharsi College Road, Bhubaneswar-751007, Odisha" and hereby appoint Deputy Registrar of Cooperative Societies, Khordha Division, O/o Registrar of Cooperative Societies, Govt. of Odisha as liquidator of the



Society under the provisions of Section 89(1) of the Act until further orders with the direction to take further necessary action as per the provision of Act & rules made thereunder.

7. The liquidator shall also submit status report showing progress made in liquidation of the Society on quarterly basis to this Office.
