**SHOW CAUSE NOTICE**


Office of Cooperative Election Authority (CEA) has informed that "Mata Ramabai Ambedkar Multi-State Cooperative Society Ltd., 69, 1<sup>st</sup> floor, DDA LIG Flats Link Road, Astha Kunj, Ashoka Pahari, Faiz Road, Karol Bagh, New Delhi-110005 submitted a request to conduct election of the members of the Board of Society. District Magistrate (Central), Govt. of NCT of Delhi who was appointed as the Returning Officer to conduct election vide letter dated 20.09.2024 has informed that Baillif from his Office visited the office address of the of the Society and found that it is in the name of Advocate Shri R. K. Singh. Thereafter, a letter dated 21.10.2024 (**copy enclosed**) was issued to the Society to clarify the position but nothing was heard from the Society in the O/o CEA.

2. Whereas, it appears that Society is not functioning at its registered address thereby violating the provisions of Multi-State Co-operative Societies (MSCS) Act, 2002 & Rules framed thereunder.

Therefore, the Chairman/ Chief Executive Officer of "Mata Ramabai Ambedkar Multi-State Cooperative Society Ltd., 69, 1<sup>st</sup> floor, DDA Flats, Link Road, Astha Kunj, Ashoka Pahari, Faiz Road, Karol Bagh, New Delhi-110005 is hereby directed to furnish an explanation in the matter within 15 days from the receipt of this Notice, failing which it would be presumed that the Society has nothing to say in the matter and further action, as deemed fit, would be initiated against the Society as per the provision of MSCS Act, 2002 and Rules framed thereunder.


Sir/Madam,
