- 8. Wide publicity to be given in the local News Paper & send SMS to members for participation/ holding of Elections in terms of provision of the MSCS Act and the rules framed there under.
- 9. Instructions for filling-up of the Format-M and N have been appended below the Format 'M' and 'N', the same should be scrupulously followed by the Returning Officer.

- 10. It is also requested to provide the requisite details about basic pay of RO and ARO and other polling officers in the enclosed Performa to claim remuneration from the society in connection with discharge of duties for conduct of election as RO/ARO/Polling personnel etc.
