As per section 45(1) of the Multi State Cooperative Societies (MSCS) Act, 2002 (as amended in 2023), the Central Government shall, by notification, establish an Authority to be known as the Co-operative Election Authority (CEA) which shall consist of a Chairperson, a Vice-Chairperson and Members not exceeding three including one woman to be appointed by the Central Government on the recommendation of the Selection Committee and it was notified on 11th March, 2024

- The Co-operative Election Authority was notified by Central Government in exercise of the powers conferred by section 45 of the Multi-State Co-operative Societies Act, 2002, (39 of 2002) and amendment (11 of 2023) on 11th March, 2024.
- Presently Co-operative Authority consists of the following:-3.

- The headquarters of the office of the Co-operative Election Authority, Ministry of Co-operation is at 9th Floor, Tower 'E', World Trade Centre, Nauroji Nagar, New Delhi-110029.
- As per Section 45-I of the MSCS Act, 2002 (as amended in 2023), the Authority 5. shall discharge the following functions, namely:
 - Conduct the elections of the multi-State co-operative society;
 - Supervise, direct and control the matters relating to preparation of electoral rolls; i. ii. and
 - Such other functions as may be prescribed. iii.
 - CEA is responsible for preparation of electoral rolls consisting of individual eligible members or/and delegates/representatives as per MSCS Act and Rules framed

thereunder and as per bye-laws, conduct of elections of Board of Directors and Office Bearers of the MSCS.

- Procedure for requesting election: Steps to submit election request through CRCS 6. Portal are as follows:
 - Log in to the CRCS portal (https://crcs.gov.in/) using the credentials (ID & Password of the Society.
 - Navigate to the "Election Request" section. ii.
 - Fill the required details completely and accurately in the respective field. iii.
 - Attach necessary documents in the portal in PDF: iv.
 - a. Election Request signed by Chairperson &CEO/MD of Society;
 - b. Resolution of present Board of Directors to conduct election;
 - c. Previous schedules of election of Members of Board of Directors and Office Bearers including proceedings of Returning Officers;
 - d. Latest approved Bye-Laws of the Society; and
 - e. Fact sheet signed Chairperson &CEO/MD of Society
 - Submit the request online. ٧.
 - The Authority has issued One hundred twenty eight (128) Election Program from the date of its constitution and appointment Order of Returning Officer to conduct election of MSCS. Generally, District Magistrate / Collectors are appointed as Returning Officer.
 - Ninety one (91) elections of Board of Directors & Office Bearers have been successfully conducted under supervision of CEA.
 - Thirty seven (37) elections of Board of Directors and of Office Bearers are ongoing 9. as per election program approved by CEA.
