Instructions regarding Candidate's responsibilities to keep account of election expenses: The provisions of MSCS Rules 19(U), (V), (W), (X) relating to expenditure to be incurred by the candidate in connection with elections are annexed herewith. RO is requested that these may be pasted on the Notice Board and a copy may also be supplied to the person filing the nomination.

10. Wide publicity be given for holding of Elections in terms of provision of the MSCS Act and the rules framed thereunder including advertisement in each state of operation. RO shall also issue a press release.
