SHOW CAUSE NOTICE

Sub.: Unauthorized conduct of election by National Industries Development Cooperative Federation Ltd of their own - Reg.

Chairman of National Industries Development Cooperative Federation Ltd vide letter dated 16.02.2025 informed that the society of their own appointed the RO and conducted the election of Board of Director and elected the Office Bearer.

2. Whereas, the Multi State Cooperative Societies (Amendment) Act, 2023 has been notified vide gazette notification dated 03.08.2023 and the MSCS Amendment Rules, 2023 have been notified vide gazette notification dated 04.08.2023.

3. Whereas, as per Section 45(1) of the MSCS (Amendment) Act 2023, the Central Government, by notification dated 11.03.2024 has established Cooperative Election Authority (CEA) to conduct election of Board of Directors and Office Bearers of MSCS in free, fair & transparent manner.

4. Whereas, as per Section 45-1 of MSCS (Amendment) Act 2023, the Authority is discharging the following functions, namely:

(i) conduct the elections of the multi-State co-operative society;

(ii) supervise, direct and control the matters relating to preparation of electoral rolls; and

(iii) such other functions as may be prescribed.

5. It is clear from the foregoing, conduct of election of Board of Director & Office Bearer of the aforesaid society has not been undertaken by CEA, therefore, the election which purportedly done by society of their own are illegal

6. Therefore, in exercise of the power conferred by Section 45-1 (i) & 45-L of the MSCS (Amendment) Act 2023, the Chief Executive Officer/Managing Director of National Industries Development Cooperative Federation Ltd, is hereby directed to explain as to why the action should not be taken against the society / C.E.O. for violating the provision of MSCS Act & Rules including disqualifying and going directors attract provision of Section 45 (2). It is directed to appear before the Cooperative Election Authority on 20.03.2025 at 3 pm in the office at 9th Floor, Tower-E, World Trade Center, Nauroji Nagar, Delhi-110029 to explain the matter along with PPT (format attached).



7. If the Chief Executive Officer / Managing Director of the society does not appear before the Authority, accordingly, further action will be initiated as per provision of MSCS Act, 2002 as amended in 2023 & rules made there under.

8. This issues with the approval of Cooperative Election Authority.
