**TO WHOM SO EVER IT MAY CONCERN**

Whereas, **Vaikunth Multistate Cooperative Group Housing Society Ltd., No.34, Pocket-6, Sector-12, Dwarka, New Delhi-75** (Regn No.: MSCS/CR/1034/2014) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies Act, 2002 and Rules made thereunder (hereinafter referred as Act).

2. A proposal dated 16.01.2025, was received on 20.02.2025 from Chairman and CEO of the Society for changing login ID Credentials of the Society on the CRCS portal i.e., crcs.gov.in. After examining the proposal, it was observed that last election of the society was held on 11.11.2019 and tenure of existing members of the board of Directors have been expired. As per Rules 19H of MSCS Rules, 2002, the Chairperson and the Chief Executive shall inform the Co-operative Election Authority at least six months before the expiry of the term of the board, to conduct elections within time.

3. As per records, the Society has also not filed its mandatory annual returns u/s 120 of the MSCS Act, 2002 on the CRCS Office portal.

4. A hearing (though Video Conference) was held on 05.03.2025 with the Chairman and CEO of the Society to explain the matter along with relevant documents. During the hearing, Chairman and CEO of the Society failed to provide any satisfactory reply for not conducting election within the stipulated time period and submitting mandatory annual returns to this Office and it appeared that the Society is not functioning as per the provisions of the MSCS Act, 2002 and Rules framed thereunder, its approved bye-laws and Cooperative Principles.



5. Therefore, it has been decided to initiate winding up process of the Society under the provisions of the MSCS Act, 2002 and Rules made thereunder. In case of any objection, the same may be brought to the Notice of this Authority within 15 days from the date of uploading this Notice on the official website i.e. [www.crcs.gov.in](http://www.crcs.gov.in) failing which it will be presumed that the Society has nothing to say and action would be initiated for winding up of the Society under the provisions of MSCS Act, 2002 and rules made thereunder.
