ORDER

Subject: <u>Reconduct of Election of Lucknow Division Insurance</u> Employees Cooperative Credit Society Ltd., Lucknow.

Whereas the Cooperative Election Authority (CEA) has been entrusted with the function u/s 45-I of the Multi State Cooperative Society Act 2002 (MSCS Act) to conduct elections of the Multi State Cooperative Societies (MSCS) and also to supervise, direct and control the matters relating to preparation of electoral rolls. Accordingly, in exercise of its mandate u/s 45K (1) of the MSCS Act read with Rule 19F(a) of MSCS Rules 2002, CEA appointed District Magistrate/ Collector, Lucknow as the Returning Officer for conduct of elections for fifteen (15) Board Members and for two (2) Office Bearers, i.e., Chairperson and Vice-Chairperson vide its Order of even number dated 16th January, 2025. The schedule of election was from 17.02.2025 to 24.3.2025. In the election programme, scheduled date of receiving of resolution/name of delegate from organisation was indicated as 17.02.2025. A copy of the Order dated 16.01.2025 and Election Programme is enclosed.

2. Whereas the Chief Executive Officer (CEO) of the Lucknow Division Insurance Employees Cooperative Credit Society Ltd vide its email dated 03.02.2025 requested postponement of elections and suggested a schedule where elections to begin from 10th of February, 2025. In the interest of conduct of elections, the matter was considered in the CEA and vide Order dated 12th February, 2025 revised programme envisaging commencement of delegate elections from 10th of February, 2025.

3. Whereas a Writ-C No.2184 of 2025 was filed before the Lucknow Bench of High Court of Judicature at Allahabad praying the following: -

(i) Issue a Writ, order or direction, in the nature of Certiorari thereby quashing the illegal order dated 12.02.2025 passed by opposite party no.1 by means of which Election Process of Lucknow Mandal Insurance Employees Cooperative Credit Society 2025, as contained as Annexure No.1 to writ petition.

(ii) Issue a writ, order of direction, in the nature of Mandamus commanding the Central Registrar, opposite party No.1 to please extend the election process.

(iii) Issue any other Writ, Order or direction which this Hon'ble Court may deem fit and proper in the circumstances of the case.

4. The matter in the above case was listed on 10.04.2025 and Hon'ble Lucknow Bench of High Court of Judicature at Allahabad passed the following Order: -

 None appears for the petitioner, however, Shri S.B. Pandey, learned Senior Advocate & D.S.G.I. assisted by Shri Varun Pandey, learned Counsel for the opposite party No.1, Shri Manish Mani Sharma, learned Counsel for the opposite party No.2 and learned Standing Counsel for the State are present.

2. The writ petition is dismissed for want of prosecution.

5. In the meantime, RO, vide his letter dated 24.03.2025 has sent the Form 19M for seeking prior approval of Board of Directors of the CEA, under Rule 19M (1) applicable in cases of unopposed election with respect to constitution of Board of the Society.

6. The recommendation of RO and other developments including filing of Writ Petitions were discussed in CEA's meeting held on 16.04.2025 and observed the followings:

- Non-compliance of the instructions contained in Election Programme issued by CEA on 16.01.2025 by Returning Officer as well as CEO of the Society.
- Issue of revised programme by CEA on 12.02.2025 where the elections commenced from 10.02.2025.
- (iii) Lack of publicity and advertisement etc has not been done and therefore, instructions contained in the Order dated 16.01.2025 of CEA and the various provisions of the MSCS Act have not been complied with, raising a doubt about free & fair conduct of elections; and
- (iv) Filing of Writ Petition in Lucknow Bench of Hon'ble High Court of Judicature at Allahabad wherein the issue raised by petitioner are relevant and hits at the core of free, fair & transparent election.

7. In view of forgoing, the Cooperative Election Authority has decided not to accept the recommendation of RO in Form 19M dated 24.3.2025 and decided to conduct of elections, afresh from the "delegate stage".

8. A revised schedule/Election Programme commencing from 07.07.2025 is enclosed. RO is requested to take all steps to implement the schedule of election aimed at constitution of Board of Director and Office Bearers. The term of the existing Board has already expired. CEO is directed to extend all cooperation to the Returning Officer in free & fair conduct of election.



9. All remaining instructions as contained in ORDER of CEA dated 16.01.2025 will remain unchanged. Similarly, Shri Rakesh Kumar Singh, Additional District Magistrate, (Finance & Revenue) Lucknow appointed as ARO vide order dated 27.02.2025 and Deputy Registrar of Cooperative Society, Lucknow appointed as ARO for delegate election vide Order dated 12.02.2025 will continue to perform assigned role.

10. **Delegate Election**: CEO in consultation with ARO may draw up schedule of delegate election in such a manner that the list of delegates reaches on or before 7th July, 2025 to the Returning Officer.

4. Delegate election to be conducted by CEO/Secretary (under the supervision of Returning Officer) of the society and list of elected delegates submitted to Returning Officer before 17th February, 2025.

5. In view of Rule 19(H)(2) of the MSCS Rule 2002 (as amended in 2023), the Election Program for conducting election of the aforementioned Society is enclosed. RO is requested to ensure the election is conducted as per the MSCS Act, 2002 and Rules framed there under.

6. After conduct of Elections of Board of Directors, the RO is mandated to submit the requisite details in Format 19 M (for members of the Board of Directors) under Rule 19 M for seeking prior approval of the Cooperative Election Authority

7. After conduct of Elections of Office Bearer (One Chairman & One Vice-Chairman), the RO shall submit the requisite details in Format 19 N for seeking **prior approval** of CEA before declaration of results.

8. Returning Officer shall ensure that the Society prominently displays the List of Eligible Voters, Election Program and Final List of the Contesting Candidates, and other related important documents on the website of the society for enabling free, fair and transparent elections.

9. Wide publicity to be given for holding of Elections in terms of provision of the MSCS Act and the rules framed there under.

10. Instructions for filling-up of the Format-M and N have been appended below the Format 'M' and 'N', the same should be scrupulously followed by the Returning Officer.

11. It is also requested to provide the requisite details about basic pay of RO and ARO and other polling officers in the enclosed Performa to claim remuneration from the society in connection with discharge of duties for conduct of election as RO/ARO/Polling personnel etc.
