**ORDER**

(Under section 86 of the Multi-State Co-operative Societies Act, 2002)

Whereas, **Lustiness Janhit Credit Cooperative Society Ltd., 77-B, Chhatterpur Enclave, Maidan Garhi Road, New Delhi-110074** (Regn.No. MSCS/CR/756/2013) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies Act, 2002 and Rules framed thereunder (hereinafter referred as Act).

2. A complaint dated 06.11.2024 was received from Shri Satyendra Chaturvedi, Madhya Pradesh regarding the non-payment of deposit by Lustiness Janhit Credit Cooperative Society Ltd. in this Office. Vide letter dated 24.12.2024, this complaint was forwarded to the Society for providing comments on the same within 15 days. However, no reply was received from the Society in this regard in the Office. Further, vide letter dated 24.12.2024, the Registrar of Cooperative Societies, Govt. of NCT of Delhi was requested to conduct inspection of the Society u/s 108 of the MSCS Act, 2002 and Rules framed thereunder.

3. Hon'ble High Court of Madhya Pradesh, Jabalpur and Gwalior Bench in the matter of following Writ Petitions, filed by the depositors of the Society regarding non-repayment of their matured deposits by the Society, passed orders dated 25.11.2024, 08.11.2024 and 13.12.2024 and directed Central Registrar of Cooperative Societies to consider and dispose off the representation of the petitioners:

- a. WP No. 31079 of 2024 - Dalchand Kushwaha & Ors Vs. Union of India & Ors;
- b. WP No. 33369 of 2024 - Shan Singh Rajput & Ors Vs. Union of India & Ors;
- c. WP No.30160 of 2024 - Praveen Kumar Yadav & Ors Vs. Union of India & Ors;

4. In compliance of of the Hon'ble High Court's above Orders, vide Orders dated 11.02.2025, representations of the above petitioners - Shri Dalchand Kushwaha & Ors, Shri Sohan Singh Rajput & Ors and Shri Praveen Kumar Yadav & Ors. regarding non-repayment of deposits by the Society, the Society was directed for taking immediate action as per norms under intimation to this Office. However, above orders have been returned undelivered to this Office with remark of the postal department - 'No such person is residing (NSPR)'.





5. Also, during physical verification of multi-State cooperative societies having registered office in NCT of Delhi conducted by the officials of this office, the above Society was not found functioning at its registered address i.e. 77-B, Chhattarpur Enclave, Maidan Garhi Road, New Delhi-110074. Further, Society has also not filed its mandatory annual return in this Office. This office has received many other complaints against the Society regarding the non-repayment of the deposit to the depositors and it appears that the Society is not functioning at its registered address as per the provisions of the MSCS Act, 2002, Rules framed thereunder, its approved bye-laws and Co-operative Principles.

6. To provide a final opportunity to the Society, a Notice dated 10.03.2025 was issued for seeking objection to initiate process of winding up of the Society, if any, within 15 days from the date of uploading of Notice on the Official Website i.e., [www.crcs.gov.in](http://www.crcs.gov.in). But no reply/ objection was received from the Society in this regard in the Office. Therefore, it is decided to initiate winding up of the Society under the provision of the Act and Rules made thereunder.

8. Now, therefore, after careful consideration of the facts, I, Rabindra Kumar Agarwal, Central Registrar of Cooperative Societies in exercise of the powers conferred under Section 86 of the Act, order winding up of " Lustiness Janhit Credit Cooperative Society Ltd., 77-B, Chhattarpur Enclave, Maidan Garhi Road, New Delhi-110074" and hereby appoint Deputy Commissioner/District Magistrate District South West, Govt. of NCT of Delhi as liquidator of the Society under the provisions of Section 89(1) of the Act until further orders with the direction to take further necessary action as per the provision of Act & rules made thereunder.

9. The liquidator shall also submit status report showing progress made in liquidation of the Society on quarterly basis to this Office.
