
2. Name and address of the Board of Directors are as indicated by RO in Format 19 M (Under Rule 19 M). You are requested to declare the result.

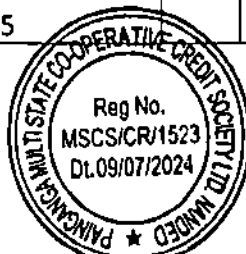


