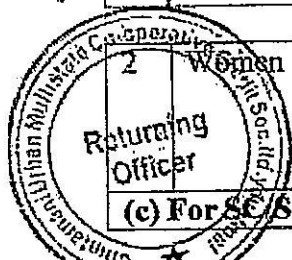

4. Each page of the Format 19M Should be signed by the Returning Officer along with has seal.
5. Over-writing should be strictly avoided.
6. The Returning Officer should indicate has mobile number to established direct communication in case of any clarification. It may be noted that time period between conduct of elections of Board of Directors and of Office Bearers of the Society is limited.
