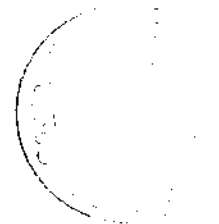

Returning Officer.


