#### ORDER

In exercise of the powers conferred by Section 45 K (1) of the Multi-State Co-operative Societies (MSCS) Act 2002, as amended by the MSCS amendment Act 2023 read with Rule 19F (a) of the MSCS Rules 2002, as amended with MSCS Rules in 2023, the Co-operative Election Authority hereby appoints District Magistrate/Collector, Ahmednagar/Ahilyanagar as Returning Officer for conducting Elections of Chairman of Omchaitnya Multi State Agro Purpose Cooperative Society Limited, Ahmednagar.

- 2. RO is requested to ensure the election is conducted as per the MSCS Act, 2002 as amended by MSCS (Amendment) Act 2023 and Rules framed thereunder. In case any provision of Registered Bye-Laws of the Society is inconsistent with the provision of Act and Rules made thereunder, then provisions of the Act/Rules shall prevail over such inconsistent provision and decision taken by CEA in this regard shall be final.
- 3. RO may submit proposal for appointment of ARO.
- **Report to CEA on nomination:** RO to submit the list of final contesting candidate after withdrawal stage to CEA through e-mail.
- 5. <u>Prior approval of result of (only for post of Chairman)</u>: After conduct of elections of Office Bearers, the RO shall submit the requisite details in Format 19-N for seeking prior approval of CEA before declaration of results.
- 6. <u>Display of Notification/orders on website of society</u>: Returning Officer shall ensure that the Society prominently displays the List of Eligible Members of Board of Directors, Election Programme and Final List of the Contesting Candidates, and other related important documents on the website of the Society prominently on the right-hand top corner of website in a box under the heading of "ELECTION FOR THE POST OF CHAIRMAN" for enabling free, fair and transparent elections.



- 7. Wide publicity be given for holding of Elections in terms of provision of the MSCS Act and the rules framed thereunder. Individual notice to all the directors may be issued.
- 8. Instructions for filling-up of the Format- N have been appended below the Format N, the same should be scrupulously followed by the Returning Office
- 9. <u>Payment of Remuneration-</u> It is also requested to provide the requisite details about basic pay of RO and ARO and other polling officers in the enclosed Performa along with a copy of cancelled cheque & PAN Card to claim remuneration from the Society in connection with discharge of duties for conduct of election as RO/ARO/Polling personnel etc.
- 10. The election programme for the post of Chairman is **enclosed**. Returning Officer may ensure that election of Chairman is conducted as per Act & Rules and Bye-Laws of Society. If there are inconsistency between Bye-Laws and Act/Rules then provisions as contained in Act/Rules will prevail over the Bye-Laws of the Society.
- 11. RO is also requested to obtain the additional information from Directors (elected) at the time of filing nomination in the form of affidavit for the post of Chairman in the following format at the time of filing nomination to ensure compliance of Section 44 of the MSCS Act:
