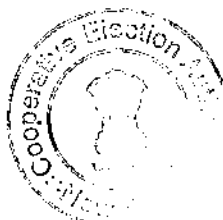
**Subject: Non-Conduct of Election of Northern Zone Railway Employee CTC Society Limited, New Delhi-reg.**

A letter no. BRMS/ORG/2025 dated 18.06.2025 has been received from Shri Santosh Kumar Patel, Secretary General of Bharatiya Railway Mazdoor Sangh regarding election of Northern Zone Railway Employee CTC Society Limited, New.

2. Whereas, the Cooperative Election Authority has been constituted under section 45(1) of the MSCS Act 2002 (as amended in 2023). The CEA, inter-alia, has been mandated for preparation of electoral roll and conduct of elections of all multi-state cooperative societies including casual vacancies under Rule 19Y. Conduct of timely elections has now become imperative exercise as the previous provisions, which permitted continuation of Board of Directors of the society beyond the tenure of the Board of Directors till the elections are held, has now been deleted from the MSCS Act 2002. To conduct timely elections, a new section, i.e., Section 45J (8) has been inserted in 2023, which reads as under: -

***“The Chairperson and the Chief Executive of the Multi State Cooperative Society shall inform the Authority, six months before the expiry of the term of the existing board, to conduct the elections within time.”***

3. Whereas, the last election of Northern Zone Railway Employee CTC Society Limited, New Delhi was held on 03.02.2020 and the tenure of Board has been expired on 03.02.2025. Continuation of Board of Directors beyond 5 years' period from the last constituted Board is illegal.



4. Therefore, in exercise of the power conferred by Section 45-I (i) & 45-L of the MSCS (Amendment) Act 2023, the Chief Executive Officer/Managing Director of Northern Zone Railway Employee CTC Society Limited, New Delhi, is hereby directed to **appear before the Cooperative Election Authority on 19.08.2025 at 3 pm** with PPT in attached format in the office at 9th Floor' Tower-E, World Trade Center, Nauroji Nagar, Delhi-110029 to explain the matter.
