l am directed to refer to your email dated 18.07.2025 and to draw attention to section 49 (2) (aa) of the Multi State Cooperative Society Act, 2002 as amended in 2023 (In short "the Act") which provides as under:-

"to elect the Chairperson and Vice-Chairperson or President and Vice-President of the Multi-State Cooperative society from amongst the elected members of the board in accordance with the directions of the Authority".

- 2. Therefore, the Board of Directors has to necessarily elect Chairperson and Vice-Chairperson. The Act does not envisage only position of Chairman.
- 3. It is, therefore, requested that RO may conduct election of Vice-Chairman of Sonai Cooperative Dairy Ltd., Pune also and send recommendation of Office Bearers (Vice-chairperson) in format 19N to Cooperative Election Authority for approval as per mandate of the Act.
- 4. The Election Programme for the post of Office Bearers (Vice-Chairman) is enclosed. Returning Officer may ensure that election is conducted as per Act & Rules and Bye-Laws of Society. If there are inconsistency between Bye-Laws and Act/Rules then provisions as contained in Act/Rules will prevail over the Bye-Laws of the Society.
