2. Name and address of the Board of Directors are as indicated by RO in Format 19 M (Under Rule 19 M). You are requested to declare the result.

3. For conduct of elections of Office Bearers, it is requested that Rule 19N i.e. "Election of office bearers by secret ballot" be kept in view which inter-alia provide that the meeting to elect office bearers shall not be conducted unless majority of newly elected members of the board are present. Further such meeting shall be presided over by Returning Officer

4. Returning Officer is requested to refer to Section 44 of the Multi State Cooperative Societies Act, 2002 to ensure that member of the Board of Director recommended for the position of Chairperson or President has not been the Office of Chairperson or President during two consecutive terms, whether full or part. While filing nominations for Office Bearers, the following information may be obtained:

5. Returning Officer is also requested to direct CEO of Krishak Bharati Cooperative Limited, KRIBHCO, that the result of the election of Board of Director may be displayed in conspicuous manner on the website of the society.

6. The revised election programme (15.09.2025 to 16.09.2025) for the election of Office Bearers is also attached.

7. 19U—Account of election expenses-(1) Every candidate at an election shall keep a separate and correct account of all expenditure in connection with the election incurred or authorised by him between the date of the order calling the election and the date of declaration of the result thereof, both dates inclusive within the period of thirty days from the date of declaration of the result. (2) The account shall contain such particulars as may be specified from time to time in addition to the particulars referred to in rule 19W. (3) The total expenditure shall not exceed the amount as may be specified by the Authority from time to time. (4) Every contesting candidate at an election shall lodge with the Returning Officer an account of his election expenses within the time and in the manner specified by the Authority from time to time.

8. And to draw your kind attention to Rule 19-T of MSCS Act and Rules, 2002 as amended 2023 notified w.e.f. 03.06.2024:

“As per the provision of Rule 19-T of Multi State Cooperative Societies Act (Amendment) Rules 2023, an election related expenditure and other allowances and remuneration payable to the Returning Officer, Assistant Returning Officer and other Polling Personnel have to be borne by the society and paid to the CEA, which in turn is paid subsequently to RO by the CEA.”


8.1 As per approved remuneration structure, the following honorarium rates are as under:

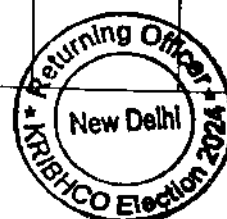

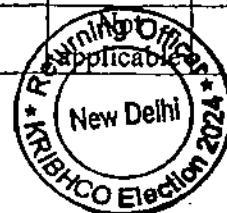

3. Date of poll is mandatorily to be written. In case no elections are held (due to lack of nomination), scheduled date of polling as in "Election Program" issued/ approved by the Cooperative Election Authority, the same date should be written as "date of poll"
4. Each page of the Format 19M should be signed by the Returning Officer along with his seal.
5. Over-writing should be strictly avoided.
6. The Returning Officer should indicate his mobile number to established direct communication in case of any clarification. It may be noted that time period between conduct of elections of Board of Directors and of Office Bearers of the society is limited.


