NOTICE

Whereas, Shri Mahankali Sahakari Shakhar Karkhana Ltd., Rajarambapu Nagar Kavathemahankal, Tal. Kavathemahankali, Sangli, Maharashtra-416405 (Regn No.: MSCS/CR/266/2008) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 and Rules made thereunder (hereinafter referred as Act).

- 2. A complaint dated 24.02.2025 (copy enclosed) was received from Shri Milind Shivputra Kore, Sangli alleging therein that members of board of the Society have been declared defaulter by District Central Cooperative Bank Ltd., Sangli and Nanasaheb Sagare Workers Cooperative Society., Kavethemahankal and further, it appears that members of the present board of the Society, does not comply with the provisions of Section 43 of the MSCS Act, 2002.
- 3. As per the records, the Society has not filed its mandatory annual returns u/s 120 of the Multi-State Cooperative Societies (MSCS) Act, 2002 on the CRCS Office portal.
- 4. Whereas, Section 43(2) of the MSCS Act, 2002 provides that "A person shall not be eligible for being elected as member of board of a multi-State co-operative society for a period of five years if the board of such multi-State co-operative society fails
 - i. To provide information, documents, personnel, funds or expenses or any other assistance as required by the Co-operative Election Authority for conducting elections under this Act in such manner as may be prescribed; or
 - ii. To call the annual general meeting under section 39; or
- iii. To prepare the financial statement and present the same in the annual general meeting; or
- iv. To make contribution to the co-operative education fund referred to in clause (b) of sub-section (1) of section 63 or the Co-operative Rehabilitation, Reconstruction and Development Fund established under section 63A; or
- v. To file annual return specified in section 120 within the time specified therein; or
- vi. To get the audit of the society conducted within six months of the close of the financial year to which such account relate;
- 5. A Letter dated 21.05.2025 followed by reminders dated 09.07.2025 and 01.08.2025 were issued to Managing Director/Chief Executive Officer of the Society, to furnish point-wise comments/reply on the above complaint of Shri Milind Shivputra

Kore and for not submitting mandatory annual returns to this office. However, no reply has been received from the Society in the Office.

- 6. Therefore, all the members of existing Board of Directors of Shri Mahankali Sahakari Shakhar Karkhana Ltd., Rajarambapu Nagar Kavathemahankal, Tal. Avathemahankali, Sangli, Maharashtra-416405 are hereby directed to furnish explanation in the matter and to explain why they should not be disqualified for contesting the election of Shri Mahankali Sahakari Shakhar Karkhana Ltd., under the provision of section 43(2) of the MSCS Act, 2002 within 15 days from the issues of this Notice on CRCS portal.
- 7. If comment/ explanation is not received within stipulated time period, it would be presumed that members of Board of Directors of the Society have nothing to say in this matter and further action, as deemed appropriate in the matter would be taken under the provision of MSCS Act, 2002 and rules framed thereunder in this regard.
