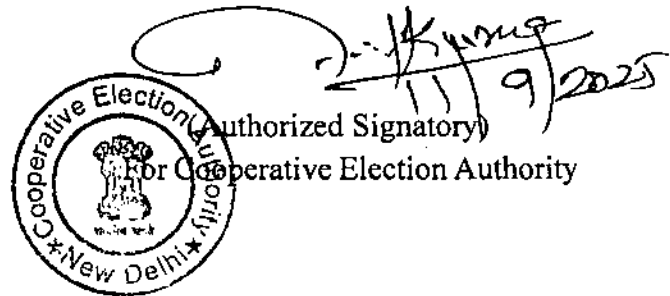
2. Name and address of the Office Bearers have been indicated by RO in Format 19 N (Under Rule 19 N). You are requested to declare the result.
