**ORDER**

Whereas, Jijau Maa Saheb Multi State Cooperative Credit Society Ltd., Beed, In front of Rashtramata Jijav Statue, Central Road, Beed, Maharashtra (Regn No.: MSCS/CR/465/2011) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 and Rules made thereunder (hereinafter referred as Act).

2. Vide Order dated 20.05.2025, Assistant Registrar, Cooperative Societies, Majalgaon, Distt. Beed, Maharashtra was appointed as Liquidator of the Society under the provision of Section 89(1) of the Act.

3. Commissioner for Cooperation and Registrar of Cooperative Societies, Govt. of Maharashtra, vide letter No. EST/D-2/Rajasthan co-op/ Shri.Mote/Liq./2025/1675 dated 19.08.2025 has recommended to appoint Assistant Registrar, Cooperative Societies, Shirur Kasar, Distt. Beed as liquidator of Jijau Maa Saheb Multi State Cooperative Society Ltd., Beed, Maharashtra in place of Assistant Registrar, Cooperative Societies, Majalgaon, Distt. Beed due to more distance between the office of the present liquidator and Society's office.

4. Now, therefore, after careful consideration of the facts, I, Rabindra Kumar Agarwal, Central Registrar of Cooperative Societies in exercise of the powers conferred under Section 89(1) of the Act, appoint Assistant Registrar, Cooperative Societies, Shirur Kasar, Distt. Beed as a Liquidator of the Society in place of Assistant Registrar, Cooperative Societies, Majalgaon, Distt. Beed until further orders to take further necessary action as per the provisions of Multi-State Cooperative Societies Act, 2002 and Rules framed thereunder.

5. The liquidator shall also submit the status report showing the progress made in liquidation of the Society on quarterly basis to this Office.
