ORDER

Whereas, Rajasthani Multi State Cooperative Credit Society Ltd., Laxmi Market, Near Dr. Wangikar Hospital, Parli, Vajinath, District Beed, Maharashtra (Regn No.: MSCS/CR/543/2012) (hereinafter referred as Society) is registered under the provisions of Multi-State Cooperative Societies (MSCS) Act, 2002 and Rules made thereunder (hereinafter referred as Act).

2. Vide Order dated 16.05.2025, Assistant Registrar, Cooperative Societies, Shirur Kasar, Distt. Beed, Maharashtra was appointed as Liquidator of the Society under the provision of Section 89(1) of the Act.

3. Commissioner for Cooperation and Registrar of Cooperative Societies, Govt. of Maharashtra, vide letter No. EST/D-2/Rajasthani co-op/Shri.Mote/Liq./2025/1675 dated 19.08.2025 has intimated that O/o Assistant Registrar, Cooperative Societies, Shirur Kasar, Beed and O/o Rajasthani Multi State Cooperative Credit Society Ltd. are nearly 135 KM apart and Assistant Registrar, Cooperative Societies, Shirur Kasar, Distt. Beed/persent liquidator has expressed his inability to manage the affairs of his regular post and liquidator simultaneously. RCS, Maharashtra further informed that distance between Majalgaon, Beed and Parli Vajinath is nearer and recommended to appoint Assistant Registrar, Majalgaon, Beed as liquidator of Rajasthani Multi State Cooperative Credit Society Ltd., Beed, Maharashtra in place of Assistant Registrar, Cooperative Societies, Shirur Kasar, Beed.

4. Now, therefore, after careful consideration of the facts, I, Rabindra Kumar Agarwal, Central Registrar of Cooperative Societies in exercise of the powers conferred under Section 89(1) of the Act, appoint Assistant Registrar, Majalgaon, Beed as a Liquidator of the Society in place of Assistant Registrar, Cooperative Societies, Shirur Kasar, Beed until further orders to take further necessary action as per the provisions of Multi-State Cooperative Societies Act, 2002 and Rules framed thereunder.

5. The liquidator shall also submit the status report showing the progress made in liquidation of the Society on quarterly basis to this Office.
