2. Name and address of the Board of Directors are as indicated by RO in Format 19 M (Under Rule 19 M). You are requested to declare the result.

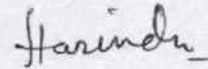

For conduct of elections of Office Bearers, it is requested that Rule 19N i.e. "Election of office bearers by secret ballot" be kept in view which inter-alia provide that the meeting to elect office bearers shall not be conducted unless majority of newly elected members of the board are present. Further such meeting shall be presided over by Returning Officer.



4. Returning Officer is also requested to direct CEO of Jay Jagannath Multi State Co-Operative Credit Society Limited that the result of the election of Board of Director may be displayed in conspicuous manner on the website of the society.
5. Returning Officer is required to preside over the meeting for the purpose of elections to the Office Bearers by secret ballot, as per Rule 19(2) of the MSCS Rules.
6. Returning Officer is also requested to ensure that society has deposited remuneration for Returning Officer/Assistant Returning Officer/Polling Officer in Cooperative Election Authority's Account.
7. **Preparation of Account and loading of the same:** From conjoint reading of the Rule 19U & Rule 19W, it is clear that all candidate shall prepare account of all expenditure in connection with the election. Account be prepared as per particulars given in Rule 19W. No limit for election expenditure for the candidate has been fixed by Cooperative Election Authority till now. The account of expenditure must be lodged with the Returning Officer within 30 days otherwise it attracts disqualification for failure to lodge account of election expenses.

1. The Returning Officer Shall Declare Result Only After Seeking Prior Approval From The Cooperative Election Authority (Rule 19M)
2. This Form Should Be Carefully Filled By Returning Officer And Ensure That Each And Every Column Is Filled Up And No Column Is Left Blank. In Case Information Asked Is Not Relevant, Then Write "Not Applicable"
3. Date Of Poll Is Mandatorily To Be Written. In Case No Elections Are Held (Due To Lack Of Nomination), Scheduled Date Of Polling As In "Election Program" Issued/Approved By The Cooperative Election Authority, The Same Date Should Be Written As "Date Of Poll"
4. Each Page Of The Format 19M Should Be Signed By The Returning Officer Along With Has Seal.
5. Over-Writing Should Be Strictly Avoided.
6. The Returning Officer Should Indicate Has Mobile Number To Established Direct Communication In Case Of Any Clarification. It May Be Noted That Time Period Between Conduct Of Elections Of Board Of Directors And Of Office Bearers Of The Society Is Limited.
7. This Form Should Be Submitted To Office Of Cooperative Election Authority, 9th Floor, Tower-W, World Trade Center, Nauroji Nagar, Delhi-110029 Through Email (cea-2023@gov.in) And By Speed Post With A Covering Letter Under Signature & Seal Of Returning Officer.
