2. The Society/RO must ensure that wide publicity is given for change of election program through newspapers, display of revised program on the website of the Society.

3. RO may devise a suitable procedure for decentralized counting of votes. RO may also prescribe a proforma to receive result to be signed by respective authorized officer at decentralized counting center. RO may also ensure that the ballot boxes are transported in safe & secure manner and the boxes are sealed. All candidate or their representative should be given prior intimation to remain present, if desired and append their signature on counting sheets and also append signature, if desired on the seals of ballot boxes.

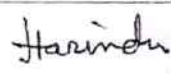
