Sir,

I am directed to say that Election programme of Deshbhakta Ratnappanna Kumbhar Panchaganga Sahakari Sakhar Karkhana Ltd, Kolhapur was issued on 05.12.2024. Returning Officer had submitted Form 19M vide letter dated 21.01.2025 recommending the names of the Board of Directors for seeking prior approval of Authority. However, the recommendation of the Returning Officer was not accepted by Authority and the Authority vide its order dated 3rd April, 2025, decided to reconvene the election from the stage of inviting nomination afresh. However, a stay on this program was granted by the Hon'ble High Court vide order dated 25.04.2025.

2. In compliance with the directions of Hon'ble High Court of Judicature at Bombay dated 25.04.2025, hearing was given to concerned parties by CEA and a speaking order was passed on 14.07.2025 by the Cooperative Election Authority.



- 3. Subsequently after hearing and arguments, Hon'ble High Court of Judicature at Bombay issued order in WP No. 5418 of 2025 with WP No. 11038 of 2025 on 06.11.2025 and allowed the requests/prayers of petitioners.
- 4. Subsequently, an appeal no. 34668-34669/2025 was filed in Hon'ble Supreme Court of India and it was heard on 01.12.2025. The Hon'ble Supreme Court passed an order "We are not inclined to interfere with the impugned judgement(s)/order(s) of the High Court. Accordingly, the Special Leave Petitions are dismissed. Pending application(s), if any, shall stand disposed off."
- 5. In compliance of orders passed by Hon'ble High Court and Hon'ble Supreme Court, the undersigned is directed to convey the approval of 19 M as per your recommendations received through above mentioned reference at sl.no.1 regarding election of Board of Directors of Deshbhakta Ratnappanna Kumbhar Panchaganga Sahakari Sakhar Karkhana Ltd, in the Format 19M as per following details:


